**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LINE OF
AUTHORITY AND NOTICE OF
OPPORTUNITY FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Scott Allen Zealley** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Scott Allen Zealley ("Respondent") is licensed as a resident accident/health and life producer and bail bond agent, Arizona license number 207552, which expires on July 31, 2013.

2. Respondent's addresses of record are: 5651 W. Talavi Blvd., Glendale, Arizona 85306 (business); c/o Bankers Life & Casualty, 5651 W. Talavi Blvd., Glendale, Arizona 85306 (mailing); and 7732 W. Mescal St., Peoria, Arizona 85354 (residence).

3. On March 4, 2011, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective thirty (30) days after receipt of the notice.
