

1 **NOTICE**

2 The determination set forth in this Order is an “appealable agency action” pursuant to A.R.S. §41-
3 1092. Consequently, you have the right to obtain a hearing on this determination by filing a Notice of
4 Appeal within thirty (30) days after your receipt of this order. If your Notice of Appeal is received after
5 that thirty (30) day period, it will not be accepted without a demonstration of good cause for the late
6 filing. The Notice of Appeal must identify the party appealing, the party’s address, the determination
7 appealed and must contain a concise statement of the reasons for the appeal. Your hearing will be held
8 within sixty (60) days after your Notice of Appeal is filed, unless the hearing is advanced or delayed by
9 agreement or a showing of good cause by any party. The Department of Insurance will serve a Notice of
10 Hearing at least thirty (30) days before the hearing, which will inform you of the date, time and location
11 of the hearing as well as the issues in controversy.

12 If you file a Notice of Appeal, you may also request an Informal Settlement Conference by filing a
13 written request no later than twenty (20) days before the scheduled hearing. The conference will be held
14 within fifteen (15) days of your request. If an Informal Settlement Conference is requested, a person with
15 the authority to act on behalf of the Department of Insurance will be present. Please note that you waive
16 any right to object to the participation of the Department’s representative in the final administrative
17 decision of the matter if it is not settled.
