
**ORDER VACATING CORRECTIVE ORDER**

On July 21, 2003, the Director of the Arizona Department of Insurance ("Director") issued a Corrective Order based on a determination that Republic Western Insurance Company ("RWIC") was in a hazardous condition within the meaning of A.A.C. R20-6-308(A)(8),(9) and (13). The Corrective Order followed the May 20, 2003 Notice of Determination, Order for Supervision and Consent Thereto ("Supervision Order"). The Director required RWIC to take certain corrective actions related to the limitation of risks on insurance business with affiliates and to provide a plan evidencing that RWIC was in compliance with various requirements of A.R.S. Title 20 in conjunction with the discharge of RWIC's parent company, AMERCO, from bankruptcy. The Director abated the RWIC Supervision Order on June 9, 2005.

In light of the abatement of the supervision, and after consideration of other factors including RWIC's annual statement as of December 31, 2005, the Director determines that RWIC is no longer in hazardous condition within the meaning of Rule 308, and the Corrective Order is no longer necessary.

1 THEREFORE, IT IS ORDERED vacating the July 21, 2003 Corrective Order.
