**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Christopher John Chesson** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Christopher John Chesson ("Respondent") is licensed as a bail bond agent, Arizona License Number 199633 which expires on June 30, 2008.

2. Respondent's addresses of record with the Department are: c/o Garcia Bail Bonds, 45 W. Jefferson #32, Phoenix, Arizona 85003 (business); 4123 W. Osborn, Phoenix, Arizona 85019 (mailing and residence).

2. On January 20, 2006, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled on April 19, 2006.


