**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LICENSE  
AND NOTICE OF OPPORTUNITY  
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Matthew James Worthen** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

1. Matthew James Worthen ("Respondent") is licensed as a bail bond agent, Arizona License Number 202528 which expires on September 30, 2008.

2. Respondent's addresses of record with the Department are: c/o Don's Better Bail Bonds, 3116 N. Scottsdale Rd., #B, Scottsdale, Arizona 85251 (business); 13820 S. 44<sup>th</sup> Street, #1325, Phoenix, Arizona 85044 (residence).

2. On May 4, 2006, the insurer holding Respondent's surety bond notified the Department and Respondent that Respondent's bail agent bond was to be cancelled in 30 days.
