LAW AND ORDER**

On December 7, 2006, the Arizona Department of Insurance ("Department") issued a Notice of Hearing ("Notice") in the above-captioned matter, a copy of which is attached and incorporated by this reference. The Notice required Steven Craig Bond ("Bond") and B B Financial Benefits Group, Inc., to provide a written answer to the allegations set forth in the Notice within twenty days of the issuance of the Notice. As of this date, Respondents have failed to file an answer. On January 3, 2007, counsel for the Department filed a Request for Default and Proposed Findings of Fact, Conclusions of Law and Order. As of this date, Respondents have not responded to the Department's request. Pursuant to A.A.C.R20-6-106(D), a party that fails to file an answer within the time provided shall be deemed to be in default and one or more of the allegations in the Notice of Hearing may be deemed to be admitted.

FINDINGS OF FACT

1. Notice was proper.
2. Respondents are in default.
3. The allegations in the Notice are deemed admitted.

ORDER

IT IS ORDERED:

1. The insurance licenses held by Respondents are revoked effective upon the issuance of this Order.

2. The hearing set for January 31, 2007, at 9:00 a.m. shall be vacated.
