ORDER

Based upon reliable evidence provided to the Director of Insurance by the Assistant Director of the Financial Affairs Division of the Department of Insurance, the Director finds as follows:

1. Petitioner, CM Assurance Company, NAIC No. 76830, is a foreign insurer domiciled in Connecticut. Petitioner received its certificate of authority to transact life and disability insurance in Arizona on January 31, 1989.

2. Petitioner's Certificate of Dissolution was approved by the State of Connecticut Insurance Department on December 27, 2006. The Certificate of Disclosure was filed with the Connecticut Secretary of State on December 28, 2006.

3. Petitioner seeks to withdraw from the insurance business in Arizona and has voluntarily surrendered its certificate of authority to the Director.

1 4. Petitioner has no obligations under any policy of insurance to any
2 policyholders or claimants who are residents of Arizona.

3 5. Petitioner is not the subject of any pending investigation or market conduct
4 examination, and Petitioner does not owe this Department any filings or fees.

5 6. Petitioner has deposited \$100.00 which has been credited to the Insurance
6 Examiners' Revolving Fund ("IERF") pursuant to A.R.S. § 20-159.

7 IT IS ORDERED that:

8 1. The surrender of the Petitioner's certificate of authority is accepted.

9 2. The \$100.00 deposited by Petitioner which has been credited to the IERF
10 shall be released to Petitioner.
