

1 The Director of the Department has no personal liability for the release of such
2 deposit so made by her in good faith as provided for in A.R.S. § 20-588(B).

3 4. The sum of \$100.00 previously credited to the IERF shall be refunded to
4 Petitioner pursuant to A.R.S. § 20-159.

5 5. Petitioner shall file its 2007 Annual Statement with the Department, together
6 with all applicable fees, unless Petitioner files its Articles of Dissolution with the Arizona
7 Corporation Commission on or before December 31, 2007.


8 6. Petitioner shall pay its 2008 Certificate of Authority renewal fee to the
9 Department if Petitioner's Articles of Dissolution are not filed with the Arizona Corporation
10 Commission on or before March 31, 2008.

11 NOTIFICATION OF RIGHTS

12 Pursuant to Arizona Revised Statutes ("A.R.S.") § 41-1092.09, Petitioner may
13 request a rehearing with respect to this order by filling a written motion with the Director of
14 the Department of Insurance within 30 days of the date of this Order, setting forth the basis
15 for relief under A.A.C. R20-6-114(B). Pursuant to A.R.S. § 41-1092.09, it is not necessary
16 to request a rehearing before filing an appeal to Superior Court.

17 Petitioner may appeal the final decision of the Director to the Superior Court of
18 Maricopa County for judicial review pursuant to A.R.S. § 20-166. A party filing an appeal
19 must notify the Office of Administrative Hearings of the appeal within ten days after filing
20 the complaint commencing the appeal, pursuant to A.R.S. § 12-904(B).
