**ORDER**

On March 12, 2008, the Office of Administrative Hearings, through Administrative Law Judge ("ALJ") Lewis Kowal, issued an Administrative Law Judge Decision ("Recommended Decision"), received by the Director of the Department of Insurance ("Director") on March 17, 2008, a copy of which is attached and incorporated by this reference. The Director of the Department of Insurance has reviewed the Recommended Decision and enters the following Order:

1. The Recommended Findings of Fact and Conclusions of Law are adopted.
2. Petitioner may file its Articles of Amendment to its Articles of Incorporation ("Articles of Amendment") with the Arizona Corporation Commission ("ACC").
3. Petitioner is entitled to the release of its statutory deposit in the sum of \$110,000.00. Petitioner's statutory deposit shall be released to Petitioner after the Department has received all of the following:
  - (a) an ACC certified copy of Petitioner's filed Articles of Amendment; and
  - (b) Petitioner's 2007 Annual Tax and Fees Report with the applicable filing fee.
4. The sum of \$100.00 previously credited to the IERF shall be refunded to Petitioner pursuant to A.R.S. § 20-159.


