**ORDER REINSTATING  
BAIL BOND AGENT  
LICENSE**

**FINDINGS OF FACT**

1. Jackie Lynn White ("Respondent") was licensed as a bail bond agent, Arizona license number 851159, which expired on April 30, 2009.

2. Respondent's addresses of record with the Department are: c/o Libra Bonding Co., 421 E. Beale St., Kingman, Arizona 86401 (business and mailing); and 3617 E. Bluebird Lane, Kingman, Arizona 86401 (residence).

3. On April 2, 2008, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled on April 27, 2008.

4. On May 20, 2008, the Department sent Respondent a letter, at her mailing address of record, notifying Respondent that she had failed to maintain a surety bond as required by law.

5. On August 29, 2008, the Department issued an Order Summarily Suspending Bail Bond Agent License and Notice of Opportunity for Hearing In the Matter of Jackie Lynn White, Docket No. 08A-138-INS.

6. On or about May 11, 2009, Respondent provided evidence to the Department that she had procured a new bond.

1 CONCLUSIONS OF LAW

2 1. The Director has jurisdiction.

3 2. Respondent's conduct constitutes compliance with the requirement that each bail  
4 bond agent maintain in force while licensed a bond in favor of this State executed by a surety  
5 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

6 3. An application that is received during the one year period for the same license  
7 that expired is deemed a renewal application, within the meaning of A.R.S. §§ 20-289(E) and  
8 340.06.

9 ORDER

10 IT IS HEREBY ORDERED THAT:

11 1. With the submission of the statutorily required surety bond, renewal application  
12 and fees, Respondent's license is hereby reactivated and renewed as of May 11, 2009.
