ORDER

Based upon reliable evidence provided to the Director of Insurance by the Assistant Director of the Financial Affairs Division of the Department of Insurance, the Director finds as follows:

FINDINGS OF FACT

1. Petitioner, MII Life, Incorporated, NAIC No. 61522, is a foreign insurer domiciled in Minnesota. Petitioner received its certificate of authority to transact life and disability insurance in Arizona on February 6, 2002.

2. Petitioner seeks to withdraw from the insurance business in Arizona and has voluntarily surrendered its certificate of authority to the Director.

3. Petitioner has no obligations under any policy of insurance to any policyholders or claimants who are residents of Arizona.

4. Petitioner is not the subject of any pending investigation or market conduct examination, and Petitioner does not owe this Department any filings or fees.

5. Petitioner has deposited \$100.00 which has been credited to the Insurance Examiners' Revolving Fund ("IERF") pursuant to A.R.S. § 20-159.

1 **CONCLUSIONS OF LAW**

2 Petitioner has complied with the provisions of A.R.S. § 20-217 and with A.A.C.
3 R20-6-303, relating to the surrender of its Certificate of Authority and its withdrawal from
4 the insurance business.

5 **ORDER**

- 6 1. The surrender of the Petitioner's certificate of authority is accepted.
7 2. The \$100.00 deposited by Petitioner which has been credited to the IERF
8 shall be released to Petitioner.
