CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **Scott Arthur Helmer and Helmer Risk Management LLC** ("Respondents") violated provisions of Title 20, Arizona Revised Statutes. Respondents wish to resolve this matter without the commencement of formal proceedings, and admit the following Findings of Fact are true and consent to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Scott Arthur Helmer ("Helmer") is, and was at all material times, licensed as an Arizona resident property and casualty and surplus lines insurance producer, Arizona license number 144017, which expires March 31, 2012.

2. Helmer Risk Management, LLC ("HRM") is, and was at all material times, licensed as an Arizona resident property and casualty and surplus lines insurance producer, Arizona license number 855511, which expires January 31, 2010. Helmer is the owner/operator of HRM.

1 3. Respondents are aware of their right to notice and hearing at which they may be
2 represented by counsel, present evidence and examine witnesses. Respondents irrevocably
3 waive their right to such notice and hearing and to any court appeals relating to this Consent
4 Order.

5 4. Respondents state that no promise of any kind or nature whatsoever, except as
6 expressly contained in this Consent Order, was made to them to induce them to enter into
7 this Consent Order and that they have entered into this Consent Order voluntarily.

8 5. Respondents acknowledge that the acceptance of this Consent Order by the
9 Director settles this matter against them but does not preclude any other agency, officer, or
10 subdivision of this state, including the Department, from instituting civil or criminal
11 proceedings as may be appropriate in the future not connected with this matter or any other
12 previously resolved complaints.

13 6. Respondents acknowledge that this Consent Order is an administrative action
14 that the Department will report to the National Association of Insurance Commissioners
15 (NAIC). Respondents further acknowledge that they must report this administrative action to
16 any and all states in which they hold an insurance license and must disclose this administrative
17 action on any license application.

18 7. Scott Arthur Helmer represents that he is owner/operator of Helmer Risk
19 Management LLC and as such is authorized to enter into this Consent Order on its behalf.


