PROCEDURAL ORDER**

On January 27, 2010, the Arizona Department of Insurance ("Department") filed an Order to Cease and Desist, In the Matter of Agape Auto Service, LLC and Julie Bachman A Law Corporation, Docket No. 10A-015-INS (the "Cease and Desist Order"). The Cease and Desist Order cited a violation that occurred on or about December 29, 2008.

On April 13, 2010, Julie Bachman provided to the Department the Annual List of Manager or Managing Members and Registered Agent of Agape Auto Services, LLC for the filing period from June, 2008 to June, 2009 filed with the Nevada Secretary of State ("Filed Annual List"). The Filed Annual List shows Desert Moon Management as the sole Manager of Agape Auto Services, LLC for the period of the violation (Exhibit 1).

THEREFORE IT IS ORDERED, nunc pro tunc:

1. Changing the named Respondent on the Cease and Desist Order from Julie Bachman A Law Corporation to Desert Moon Management.

2. Changing Finding of Fact, paragraph 3 to read: Desert Moon Management was the only active manager of Agape from the period of June, 2008 to June, 2009.
