FINDINGS OF FACT

1. On March 5, 2010, the Arizona Department of Insurance ("Department") issued a Notice of Hearing ("Notice") in the above-captioned matter. Respondent failed to file an Answer to the Notice.

2. On April 30, 2010, counsel for the Department filed a Request for Default.

3. On May 14, 2010, the Department filed an Order finding Respondent in default and vacating the hearing scheduled for June 1, 2010, at 8:00 a.m. before Administrative Law Judge, Lewis Kowal.

4. On May 18, 2010, counsel for the Department provided evidence to the Department that Respondent was not served with the Request for Default. (Exhibit 1.)

CONCLUSIONS OF LAW

1. The Department's Request for Default does not meet the service requirement within the meaning of A.R.S. § 41-1092.04.

ORDER


1. Respondent's insurance producer license is reinstated, effective upon the issuance of this Order.


