**ORDER REINSTATING
LIFE AND HEALTH ADMINISTRATOR
CERTIFICATE OF REGISTRATION**

FINDINGS OF FACT

1. Wright & Co. ("Respondent") holds a certificate of registration as a life and health administrator in Arizona.
2. Respondent's address of record with the Department is: c/o Rockwood Programs, Inc., 4001 Miller Road, Wilmington, DE 19802-1999.
3. On February 10, 2010, the insurer holding Respondent's surety bond notified the Department that Respondent's life and health administrator bond was to be cancelled on March 24, 2010.
4. As of March 24, 2010, Respondent has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.
5. On May 11, 2010, the Department issued an Order Summarily Suspending Life and Health Administrator Certificate of Registration and Notice of Opportunity for Hearing In the Matter of Wright & Co. (Arizona Certificate # 2307); Docket No. 10A-067-INS.
6. On or about July 26, 2010, Respondent provided evidence to the Department that it had procured a new bond.

1 CONCLUSIONS OF LAW

2 1. The Director has jurisdiction.


3 2. Respondent's conduct constitutes compliance with the requirement that each
4 administrator possess and maintain a surety bond in a form acceptable to the director and
5 issued by a corporate surety authorized to transact business in this State, within the meaning
6 of A.R.S. § 20-485.10.

9 1. With the submission of the statutorily required surety bond, the Department
10 hereby reactivates Respondent's Arizona Certificate of Registration, # 2307, as of the date of
11 this Order.
