CONSENT ORDER

Hearing 10/22/10, 8:00 a.m.

The State of Arizona Department of Insurance ("Department") has received evidence that **Corrina Diane Halter** has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Corrina Diane Halter ("Respondent") is, and was at all material times licensed as a resident accident/health and life producer, Arizona license number 931736 which expires February 29, 2012.

2. Respondent's mailing, business and residence addresses of record with the Department are: 7337 W. Mountain View Rd., Peoria, Arizona 85345 (business, mailing and residence).

3. On or about November 6, 2008, the Department issued to Respondent an insurance license as a resident accident/health and life producer, Arizona license number 931736.

4. On January 5, 2009, the Department notified Respondent by mail at her business/ mailing/ residence address of record that her fingerprint card had been processed and returned by the Arizona Department of Public Safety (DPS) as illegible. The Department requested a replacement set of fingerprints along with a completed "Illegible Fingerprint Replacement Form" on or before February 9, 2009.

1 5. On November 23, 2009, the Department notified Respondent a second time by
2 mail at her business/ mailing/ residence address of record that it was about to initiate an
3 administrative action against her license for failure to comply with the fingerprint requirement.
The Department requested a response by December 31, 2009.

4 6. To date, Respondent has not submitted a full set of fingerprints to the
5 Department.

6 **CONCLUSIONS OF LAW**

7 1. The Director has jurisdiction over this matter.

8 2. Respondent's conduct as described above constitutes the violation of the
requirement that an applicant submit a full set of fingerprints to the Department within the
9 meaning of A.R.S. § 20-285(F)(2).

10 3. Respondent's conduct as described above constitutes providing incomplete
information in the license application within the meaning of A.R.S. § 20-295(A)(1).

11 4. Respondent's conduct as described above constitutes the violation of any
12 provision of A.R.S. Title 20 or any rule, subpoena or order of the director within the meaning of
13 A.R.S. §20-295(A)(2).

14 5. Grounds exist for the Director to suspend, revoke, or refuse to renew
Respondent's insurance license, impose a civil penalty and/or order restitution pursuant to
15 A.R.S. §§20-295(A) and (F).

3 officer, or subdivision of this state including the Department from instituting civil or criminal
4 proceedings as may be appropriate now or in the future not related to this matter.

5 6. Respondent acknowledges that this Consent Order is an administrative action
6 that the Department will report to the National Association of Insurance Commissioners
7 (NAIC). Respondent further acknowledges that she must report this administrative action to
8 any and all states in which she holds an insurance license and must disclose this
9 administrative action on any license application.


