**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Collin Eachan Bass** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Collin Eachan Bass ("Respondent") is licensed as a bail bond agent, Arizona license number 947577, which expires on December 31, 2012.
2. Respondent's addresses of record with the Department are: c/o Otto Bond & Bail, LLC, 923 Gurley Street, Suite 204, Prescott, Arizona 86301(business and mailing); 360 Finney Flats Road, #8, Camp Verde, Arizona 86322 (residence).
3. On July 29, 2010, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective August 22, 2010.

1 4. As of August 22, 2010, Respondent has not maintained a bond in favor of this
2 State executed by a surety insurer authorized to do business in this State.

3 5. The public health, safety and welfare imperatively require emergency action.

4 **CONCLUSIONS OF LAW**

5 1. The Director has jurisdiction.

6 2. Respondent's conduct constitutes a violation of the requirement that each bail
7 bond agent maintain in force while license a bond in favor of this State executed by a surety
8 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

9 3. Grounds exist to order a summary suspension within the meaning of A.R.S. §
10 41-1092.11(B).

11 **ORDER**

12 IT IS HEREBY ORDERED THAT:

13 1. Respondent's license, Arizona license number 947577, is summarily suspended
14 effective immediately.
