**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

9 The Arizona Department of Insurance (the "Department") alleges that **Jonathan**
 10 **Garabed Hassessian** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20.
 11 In light of the serious nature of these allegations, the Director of Insurance for the State of
 12 Arizona ("Director") finds that the public health, safety and welfare imperatively require
 13 emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- 15 1. Jonathan Garabed Hassessian ("Respondent") is licensed as a bail bond agent,
 16 Arizona license number 865728, which expires on May 31, 2014.
 - 17 2. Respondent's address of record with the Department is: 7581 E. Las Palmas Dr.,
 18 Prescott Valley, Arizona 86314 (business, mailing and residence).
 - 19 3. On September 13, 2010, the insurer holding Respondent's surety bond notified
 20 the Department that Respondent's bail agent bond was to be cancelled, effective October 7,
 21 2010.
 - 22 4. As of October 7, 2010, Respondent has not maintained a bond in favor of this
 23 State executed by a surety insurer authorized to do business in this State.

1 5. The public health, safety and welfare imperatively require emergency action.

2 **CONCLUSIONS OF LAW**

3 1. The Director has jurisdiction.

4 2. Respondent's conduct constitutes a violation of the requirement that each bail
5 bond agent maintain in force while license a bond in favor of this State executed by a surety
6 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.


7 3. Grounds exist to order a summary suspension within the meaning of A.R.S. §
8 41-1092.11(B).

11 1. Respondent's license, Arizona license number 865728, is summarily suspended
12 effective immediately.
