**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Charles Douglas Henry Hope** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Charles Douglas Henry Hope ("Respondent") is licensed as a bail bond agent, Arizona license number 957597, which expires on June 30, 2013.

2. Respondent's addresses of record with the Department are: c/o Easy Bail Bonds, LLC, 3012-3014 N. 16th St., Phoenix, Arizona 85016 (business and mailing); 14814 83rd Ave. Ct. NW, Gig Harbor, Washington 98329 (residence).

3. On May 6, 2010, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective July 10, 2010.

4. As of July 10, 2010, Respondent has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.

1 5. The public health, safety and welfare imperatively require emergency action.

2 **CONCLUSIONS OF LAW**

3 1. The Director has jurisdiction.

4 2. Respondent's conduct constitutes a violation of the requirement that each bail
5 bond agent maintain in force while license a bond in favor of this State executed by a surety
6 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

7 3. Grounds exist to order a summary suspension within the meaning of A.R.S. §
8 41-1092.11(B).

9 **ORDER**

10 IT IS HEREBY ORDERED THAT:

11 1. Respondent's license, Arizona license number 957597, is summarily suspended
12 effective immediately.
