**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LICENSE  
AND NOTICE OF OPPORTUNITY  
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Yvette Estrada Reyes** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

1. Yvette Estrada Reyes ("Respondent") is licensed as a bail bond agent, Arizona license number 947585, which expires on October 31, 2012.

2. Respondent's addresses of record with the Department are: c/o Rays Bail Bonds, 3231 W. Washington St., Phoenix, Arizona 85009 (business and mailing); 3637 W. Gelding Dr., Phoenix, Arizona 85053 (residence).

3. On July 19, 2010, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective August 13, 2010.

1 4. As of August 13, 2010, Respondent has not maintained a bond in favor of this  
2 State executed by a surety insurer authorized to do business in this State.

3 5. The public health, safety and welfare imperatively require emergency action.

4 **CONCLUSIONS OF LAW**

5 1. The Director has jurisdiction.

6 2. Respondent's conduct constitutes a violation of the requirement that each bail  
7 bond agent maintain in force while license a bond in favor of this State executed by a surety  
8 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.


9 3. Grounds exist to order a summary suspension within the meaning of A.R.S. §  
10 41-1092.11(B).

13 1. Respondent's license, Arizona license number 947585, is summarily suspended  
14 effective immediately.
