**ORDER REINSTATING
LICENSE**

FINDINGS OF FACT

1. Yvette Estrada Reyes ("Respondent") is licensed, Arizona license number 947585, which expires on October 31, 2012.
2. Respondent's addresses of record with the Department are: c/o Freeway Insurance, 2753 E. Broadway, Mesa, Arizona 85282 (business and mailing); 1865 E. Broadway, #413, Tempe, Arizona 85282 (residence).
3. On July 20, 2009, the Department issued license number 947585 to Respondent with one line of authority as a bail bond agent.
4. On November 5, 2010, the Department filed an Order Summarily Suspending Bail Bond Agent License and Notice of Opportunity for Hearing In the Matter of Reyes, Yvette Estrada, Docket No. 10A-148-INS ("November 5, 2010 Order"). Because license 947585 only had one line of authority as a bail bond agent, the November 5, 2010 Order suspended Respondent's entire license. Respondent did not appeal the November 5, 2010 Order.
5. On April 18, 2012, Respondent filed a Voluntary Surrender of Insurance License Form with the Department to surrender the bail bond agent line of authority.

1 6. On April 18, 2012, Respondent filed an Application for an Individual Insurance
2 License with the Department with one line of authority as a personal lines (P&C) producer.

3 **CONCLUSIONS OF LAW**


- 4 1. The Director has jurisdiction.
- 5 2. On the written request of a person who is licensed, the Director may accept the
6 voluntary surrender of the person's authority to transact one or more lines of authority, within
7 the meaning of A.R.S. § 20-289(F) as applied to bail bond agents under A.R.S. § 20-340.06.

8 **ORDER**

9 IT IS HEREBY ORDERED THAT:

- 10 1. Respondent may surrender her bail bond agent line of authority.
- 11 2. The Department shall immediately reinstate Respondent's Arizona license,
12 # 947585, with a personal lines (P&C) line of authority.
