**ORDER**

Based upon reliable evidence provided to the Director of Insurance by the Assistant  
Director of the Financial Affairs Division of the Arizona Department of Insurance  
("Department"), the Director finds as follows:

**FINDINGS OF FACT**

1. Petitioner is currently licensed in the State of Arizona as a life and disability reinsurer.
2. Petitioner surrendered its Certificate of Authority to the Department.
3. Petitioner filed with the Department certified copies of Resolutions of the Petitioner's Board of Directors and the Petitioner's shareholder(s) authorizing Petitioner to withdraw from the insurance business by dissolution.
4. Petitioner filed its certified financial statement as of September 30, 2010 with the Department.
5. Petitioner has no insurance obligations owing to it, whether by policies written direct or by reinsurance ceded to it.
6. Petitioner has a \$100.00 deposit with the Insurance Examiners' Revolving Fund ("IERF").



1           5.     Petitioner shall pay its Certificate of Authority renewal fee to the Department and  
2 file its 2010 Annual Form "B" Registration Statement with the Department unless it files  
3 Articles of Dissolution with the ACC on or before March 31, 2011.

4           6.     The Department shall refund to the Petitioner the \$100.00 that was previously  
5 credited to the IERF pursuant to A.R.S. § 20-159.

6           Effective this 31<sup>st</sup> day of December, 2010.
