CONSENT ORDER WTH KEVIN
MICHAEL GOULART

Respondents.

The State of Arizona Department of Insurance ("Department") has received evidence that **Kevin Michael Goulart** ("Respondent" or "Goulart") violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, admits the following Findings of Fact are true, and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Easy Bail Bonds, LLC ("Easy BB") is, and was at all material times licensed as an Arizona resident bail bond agent, Arizona license number, 905938, which expires on November 30, 2011.

2. Easy BB's address of record is: 3012-3014 N. 16th Street, Phoenix, Arizona 85016 (business and mailing).

3. Goulart is, and was at all times material, licensed as an Arizona resident bail bond agent, Arizona license number 876624, which expires on March 31, 2014.

1 4. Goulart was the Designated Responsible Licensed Producer of record for
2 Easy BB from June 13, 2007 until May 29, 2008.

3 5. According to the Arizona Corporation Commission's records, Goulart was
4 the Manager of Easy BB from June 13, 2007 until May 29, 2008.

5 6. On February 3, 2009, Goulart sent a letter to the Department notifying the
6 Department that he had resigned from Easy BB in April 2008 and that he had submitted
7 documents to the Department in April and May 2008. In the letter, Goulart requested that
8 he be removed from all correspondence and any paperwork that would list him having
9 any business or transactions with Easy BB.

10 7. On September 29, 2010, Goulart sent a second letter to the Department
11 notifying it that he resigned from his position as Designated Responsible Licensed
12 Producer for Easy BB and has had no business or dealings with Easy BB since April
13 2008. He informed the Department that Joseph Henry Gagnon is currently the
14 Designated Responsible Licensed Producer for Easy BB.

15 **CONCLUSIONS OF LAW**

16 8. Respondent's conduct, as described above, constitutes the violation of any
17 provision of A.R.S. Title 20 or any rule, subpoena or order of the Director within the
18 meaning of A.R.S. § 20-295(A)(2), as applied to bail bond agents under A.R.S. § 20-
19 340.06.

20 9. Respondent's conduct, as described above, constitutes failure to notify the
21 Director in writing within thirty days of any changes in the licensee's members, directors,
22 officers, or designated producer, in violation of A.R.S. § 20-286(C)(2), as applied to bail
23 bond agents under A.R.S. § 20-340.06.


