**ORDER SUMMARILY SUSPENDING
LIFE AND HEALTH ADMINISTRATOR
CERTIFICATE OF REGISTRATION
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Disability Management Alternatives, LLC dba Hewitt LCG** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Disability Management Alternatives, LLC dba Hewitt LCG ("Respondent") holds a certificate of registration as a life and health administrator in Arizona.
2. Respondent's address of record with the Department is: 1000 Milwaukee Ave., 5th Floor, Glenview, IL 60025.
3. On February 11, 2011, the insurer holding Respondent's surety bond notified the Department that Respondent's life and health administrator bond was to be cancelled effective March 11, 2011.
