12	("Director") finds that the public health, safety and welfare imperatively require emergency							
13	action, within the meaning of A.R.S. §41-1092.11(B).

15	1.	1. Kristin Marie Roossin ("Respondent") is licensed as a resident bail bond agent,						
16	Arizona license number 964544 which expires on April 30, 2014.							
17	2.	2. Respondent's addresses of record are: 139 W. Mohave, Phoenix, Arizona						
18	85003 (business and mailing) and 8863 E. Ann Way, Scottsdale, Arizona 85260 (residence).							
19	3.	3. On March 4, 2011, the insurer holding Respondent's surety bond notified the						
20	Department	Department that Respondent's bail agent bond was to be cancelled, effective thirty (30) days						
21	after receipt of the notice.							
22	4. On March 16, 2011, the Department notified Respondent that the surety holding							
	her bond was cancelling her bond effective April 4, 2011.							

1	5. To date, Respondent has failed to replace her surety bond.					
2	6. Therefore, as of April 4, 2011, Respondent has not maintained a bond in favor of					
3	this-State-executed-by-a-surety-insurer authorized to do business in this State.					
4	7. The public health, safety and welfare imperatively require emergency action.					
5	CONCLUSIONS OF LAW					
. 6	1. The Director has jurisdiction.					
7	2. Respondent's conduct constitutes a violation of the requirement that each bail					
8	bond agent maintain in force while license a bond in favor of this State executed by a surety					
9	insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.					
10	3. Grounds exist to order a summary suspension within the meaning of A.R.S. §					
11	41-1092.11(B).

14	1. Respondent's bail bond agent license, Arizona license number 964544, is					
15	summarily suspended effective immediately.
