**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

9 The Arizona Department of Insurance (the "Department") alleges that **Jason Allen**
 10 **Brown** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the
 11 serious nature of these allegations, the Director of Insurance for the State of Arizona
 12 ("Director") finds that the public health, safety and welfare imperatively require emergency
 13 action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- 15 1. Jason Allen Brown ("Respondent") is licensed as a resident bail bond agent,
 16 Arizona license number 968252 which expires on May 31, 2014.

 21 Department that Respondent's bail agent bond was to be cancelled, effective on November
