**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Gail Ruth Cordova** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Gail Ruth Cordova ("Respondent") is licensed as a resident bail bond agent, Arizona license number 966213 which expires on October 31, 2013.
2. Respondent's addresses of record are: 6802 N. 47th Ave., #5, Glendale, Arizona 85301 (business and mailing); and 4748 W. Sierra Vista Dr., #115, Glendale, Arizona 85301 (residence).
3. On June 10, 2010, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective thirty (30) days after receipt of the notice.

1 4. On October 27, 2010, the Department notified Respondent that the surety
2 holding Respondent's bond was cancelling the bond effective July 10, 2010.

3 5. To date, Respondent has failed to replace the cancelled surety bond.

4 6. Therefore, as of July 10, 2010, Respondent has not maintained a bond in favor
5 of this State executed by a surety insurer authorized to do business in this State.

6 7. The public health, safety and welfare imperatively require emergency action.

7 **CONCLUSIONS OF LAW**

8 1. The Director has jurisdiction.

9 2. Respondent's conduct constitutes a violation of the requirement that each bail
10 bond agent maintain in force while license a bond in favor of this State executed by a surety
11 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.

12 3. Grounds exist to order a summary suspension within the meaning of A.R.S. §
13 41-1092.11(B).

14 **ORDER**

15 IT IS HEREBY ORDERED THAT:

16 1. Respondent's bail bond agent license, Arizona license number 966213, is
17 summarily suspended effective immediately.
