9	The Arizona Department of Insurance (the "Department") alleges that Steven Dennis		
10	Hall has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the		
11	serious nature of these allegations, the Director of Insurance for the State of Arizona		
12	("Director") finds that the public health, safety and welfare imperatively require emergency		
13	action, within the meaning of A.R.S. §41-1092.11(B).		
14	FINDINGS OF FACT		
15	1. Steven Dennis Hall ("Respondent") is licensed as a resident bail bond agent,		
16	Arizona license number 947521 which expires on March 31, 2013.		
17	2. Respondent's addresses of record are: 3012 N. 16 th Street, Phoenix, Arizona		
18	85016 (business and mailing); and 4653 E. Gleneagle, Chandler, Arizona 85249 (residence).		
19	3. On May 6, 2010, the insurer holding Respondent's surety bond notified the		
20	Department that Respondent's bail agent bond was to be cancelled, effective on July 10, 2010		
21	or thirty (30) days from receipt of the notice, whichever is later.		
22	4. On May 7, 2010, the Department notified Respondent that the surety holding		
23	Respondent's bond was cancelling the bond effective June 6, 2010.		

- 5. To date, Respondent has failed to replace the cancelled surety bond.
- 6. Therefore, as of July 10, 2010, Respondent has not maintained a bond in favor of this State executed by a surety insurer authorized to do business in this State.
 - 7. The public health, safety and welfare imperatively require emergency action.

CONCLUSIONS OF LAW

- 1. The Director has jurisdiction.
- 2. Respondent's conduct constitutes a violation of the requirement that each bail bond agent maintain in force while license a bond in favor of this State executed by a surety insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.
- 3. Grounds exist to order a summary suspension within the meaning of A.R.S. § 41-1092.11(B).

ORDER

IT IS HEREBY ORDERED THAT:

1. Respondent's bail bond agent license, Arizona license number 947521, is summarily suspended effective immediately.
