**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

9 The Arizona Department of Insurance (the "Department") alleges that **Ryan Adam**
 10 **Mullinax** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of
 11 the serious nature of these allegations, the Director of Insurance for the State of Arizona
 12 ("Director") finds that the public health, safety and welfare imperatively require emergency
 13 action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- 14
- 15 1. Ryan Adam Mullinax ("Respondent") is licensed as a resident bail bond agent,
 16 Arizona license number 964266 which expires on April 30, 2014.
 - 17 2. Respondent's addresses of record are: 6721 N. Black Canyon Hwy, Suite C,
 18 Phoenix, Arizona 85015 (business and mailing); and 15230 N. 43rd St., Phoenix, Arizona
 19 85032 (residence).
 - 20 3. On March 4, 2011, the insurer holding Respondent's surety bond notified the
 21 Department that Respondent's bail agent bond was to be cancelled, effective thirty (30) days
 22 after receipt of the notice.

1 4. On March 16, 2011, the Department notified Respondent that the surety holding
2 Respondent's bond was cancelling the bond effective April 4, 2011.

3 5. To date, Respondent has failed to replace the cancelled surety bond.

4 6. Therefore, as of April 4, 2011, Respondent has not maintained a bond in favor of
5 this State executed by a surety insurer authorized to do business in this State.

6 7. The public health, safety and welfare imperatively require emergency action.

7 **CONCLUSIONS OF LAW**

8 1. The Director has jurisdiction.

9 2. Respondent's conduct constitutes a violation of the requirement that each bail
10 bond agent maintain in force while license a bond in favor of this State executed by a surety
11 insurer authorized to do business in this State, within the meaning of A.R.S. § 20-340.02.


12 3. Grounds exist to order a summary suspension within the meaning of A.R.S. §
13 41-1092.11(B).

16 1. Respondent's bail bond agent license, Arizona license number 964266, is
17 summarily suspended effective immediately.
