CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **Karen Teichman** has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Karen Teichman ("Respondent") is, and was at all material times licensed as a resident travel producer (limited), Arizona license number 984352, which expires November 30, 2014.

2. Respondent's mailing, business and residence address of record with the Department is: 21728 N. Limousine Dr., Sun City West, Arizona 85375 (business, mailing and residence).


3. On or about January 26, 2011, the Department issued to Respondent an insurance license as a resident travel producer (limited), Arizona license number 984352.

4. On May 11, 2011, the Department notified Respondent by mail at her business/mailling/residence address of record that her fingerprint card had been processed and returned by the Arizona Department of Public Safety (DPS) as illegible. The Department requested a replacement set of fingerprints along with a completed "Illegible Fingerprint Replacement Form" on or before June 8, 2011.

1 6. Respondent acknowledges that this Consent Order is an administrative action
2 that the Department will report to the National Association of Insurance Commissioners
3 (NAIC). Respondent further acknowledges that she must report this administrative action to
4 any and all states in which she holds an insurance license and must disclose this
5 administrative action on any license application.
