**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

9 The Arizona Department of Insurance (the "Department") alleges that **Andrew Eric**
10 **Blair** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the
11 serious nature of these allegations, the Director of Insurance for the State of Arizona
12 ("Director") finds that the public health, safety and welfare imperatively require emergency
13 action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- 15 1. Andrew Eric Blair ("Respondent") is licensed as a resident bail bond agent,
 16 Arizona license number 973243, which expires on May 31, 2014.
- 17 2. Respondent's addresses of record are: c/o Get Out Bail Bonds, LLC, 301 W.
 18 Mohave St., Phoenix, Arizona 85003 (business and mailing); 9907 E. Flanders Rd., Mesa,
 19 Arizona 85207 (residence).
- 20 3. On August 3, 2011, the insurer holding Respondent's surety bond notified the
 21 Department that Respondent's bail agent bond was to be cancelled, effective 30 days from the
 22 date of the notice.
