**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LICENSE  
AND NOTICE OF OPPORTUNITY  
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **James Michael Brown** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

1. James Michael Brown ("Respondent") is licensed as a resident bail bond agent, Arizona license number 976116, which expires on November 30, 2013.

2. Respondent's addresses of record are: 6721 N. Black Canyon Highway, Phoenix, Arizona 85015 (business); c/o Accurate Bail Bonds, 1010 E. Indian School Rd., Phoenix, Arizona 85014 (mailing); 2419 W. Seldon Lane, Phoenix, Arizona 85021 (residence).

3. On March 23, 2012, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective 30 days from the date of the notice.
