**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

9 The Arizona Department of Insurance (the "Department") alleges that **Stephen Scott**
10 **McLenna** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of
11 the serious nature of these allegations, the Director of Insurance for the State of Arizona
12 ("Director") finds that the public health, safety and welfare imperatively require emergency
13 action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- 14 1. Stephen Scott McLenna ("Respondent") is licensed as a resident bail bond
 15 agent, Arizona license number 984947, which expires on May 31, 2014.
- 16 2. Respondent's addresses of record are: 6721 N. Black Canyon Hwy, Phoenix,
 17 Arizona 85015 (business and mailing); 19565 E. Silver Creek Ln., Queen Creek, Arizona
 18 85142 (residence).
- 19 3. On February 9, 2012, the insurer holding Respondent's surety bond notified the
 20 Department that Respondent's bail agent bond was to be cancelled, effective 30 days from the
 21 date of the notice.
