**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LICENSE  
AND NOTICE OF OPPORTUNITY  
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Rhonda Piedra** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

1. Rhonda Piedra ("Respondent") is licensed as a resident bail bond agent, Arizona license number 991608, which expires on June 30, 2014.
2. Respondent's addresses of record are: c/o Ability Bonding Co Inc, 723 W. Polk St., Phoenix, Arizona 85007 (business and mailing); 62 W. Pasture Canyon Dr., San Tan Valley, Arizona 85143 (residence).
3. On January 30, 2012, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective 30 days from the date of the notice.
