

**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Robert Lawrence Ryczek** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Robert Lawrence Ryczek ("Respondent") is licensed as a resident bail bond agent, Arizona license number 973823, which expires on August 31, 2014.
2. Respondent's addresses of record are: 2125 S. 48th Street, Suite 101, Tempe, Arizona 85283 (business and mailing); 1146 E. Erie St., Gilbert, Arizona 85295 (residence).
3. On October 11, 2011, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled on November 6, 2011.
4. On October 24, 2011, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective November 11, 2011.
5. To date, Respondent has failed to replace the cancelled surety bond.
