**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE
AND NOTICE OF OPPORTUNITY
FOR HEARING**

9 The Arizona Department of Insurance (the "Department") alleges that **Ulah Marie**
 10 **Witherspoon** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light
 11 of the serious nature of these allegations, the Director of Insurance for the State of Arizona
 12 ("Director") finds that the public health, safety and welfare imperatively require emergency
 13 action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

- 15 1. Ulah Marie Witherspoon ("Respondent") is licensed as a resident bail bond
 16 agent, Arizona license number 520684, which expires on June 30, 2014.
 - 17 2. Respondent's address of record is: 3714 W. Berridge Lane, Phoenix, Arizona
 18 85019 (business, mailing and residence).
 - 19 3. On June 7, 2012, the insurer holding Respondent's surety bond notified the
 20 Department that Respondent's bail agent bond was to be cancelled, effective 30 days from the
 21 date of the notice.
 - 22 4. On June 15, 2012, the Department notified Respondent that the surety holding
 23 Respondent's bond was cancelling the bond effective July 7, 2012.
