CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **Jesus Antonio Rodriguez ("Respondent")** violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Respondent is, and was at all material times, licensed as an Arizona resident accident/health, life, variable life/variable annuities, casualty, and property insurance producer, Arizona license number 179192, which expires on June 30, 2014.

2. Respondent's addresses of record are: c/o American Family Insurance, 2340 N. Tucson Blvd, Tucson, Arizona 85716 (business/ mailing); and 3705 W. Fitzwater Ct, Tucson, AZ 85746 (residence).

3. Respondent was at all material times contracted with American Family Insurance Company ("American Family") to transact insurance on its behalf in Arizona.


1 5. Grounds exist for the Director to suspend, revoke, or refuse to renew
2 Respondent's insurance license and/or order restitution pursuant to A.R.S. §§20-295(A) and
3 (F).

4 **ORDER**

5 IT IS HEREBY ORDERED THAT:

- 6 1. Respondent's license is revoked effective immediately upon entry of this Order.
7 2. Respondent shall make restitution to American Family in the amount of
8 \$3977.00.

- 15 1. Respondent has reviewed the foregoing Findings of Fact, Conclusions of Law

17 2. Respondent admits the jurisdiction of the Director of Insurance, State of Arizona,
18 and admits the foregoing Findings of Fact and consents to the entry of the foregoing

21 represented by counsel, present evidence and examine witnesses. Respondent irrevocably

1 4. Respondent states that no promise of any kind or nature whatsoever, except as
2 expressly contained in this Consent Order, was made to him to induce him to enter into this
3 Consent Order and that he has entered into this Consent Order voluntarily.

4 5. Respondent acknowledges that the acceptance of this Consent Order by the
5 Director is solely to settle this matter against him and does not preclude any other agency,
6 officer, or subdivision of this state including the Department from instituting civil or criminal
7 proceedings as may be appropriate now or in the future.

8 6. Respondent acknowledges that this Consent Order is an administrative action
9 that the Department will report to the National Association of Insurance Commissioners (NAIC)
10 and that he may have to report this administrative action on any future licensing applications
11 either to the Department or other states' Departments of Insurance.


