The Arizona Department of Insurance ("Department") has received evidence that **Michael Blaise Mostak** has unlawfully acted as an adjuster in the State of Arizona. Accordingly, the Director of Insurance of the State of Arizona (the "Director") makes the following Findings of Fact and Conclusions of Law and enters the following Order pursuant to A.R.S. § 20-292.

FINDINGS OF FACT

1. Michael Blaise Mostak ("Respondent" or "Mostak") is not licensed with the Department as an adjuster.
2. Ace Public Adjusters, LLC ("Ace") is and was, at all material times, licensed as a resident adjuster, Arizona license number 1023311, which expires on July 31, 2016. Ace was first licensed with the Department on July 12, 2012.
3. Mostak is a member of Ace.
4. On or about August 29, 2012, Allstate Insurance Company ("Allstate") filed a Complaint with the Department against Ace.
5. On or about June 19, 2012 through August 13, 2012, Mostak adjusted, investigated or negotiated settlement of claims on behalf of 13 different insured's with eight different insurance companies for Ace.


CONCLUSIONS OF LAW
