**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LICENSE  
AND NOTICE OF OPPORTUNITY  
FOR HEARING**

9 The Arizona Department of Insurance (the "Department") alleges that **John Andrew**  
10 **Burns, Jr.** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of  
11 the serious nature of these allegations, the Director of Insurance for the State of Arizona  
12 ("Director") finds that the public health, safety and welfare imperatively require emergency  
13 action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

14  
15 1. John Andrew Burns, Jr. ("Respondent") is licensed as a resident bail bond agent,  
16 Arizona license number 961074, which expires on July 31, 2013.

17 2. Respondent's address of record is: 20226 E. Poco Calle, Queen Creek, Arizona  
18 85142 (business, mailing and residence).

19 3. On August 6, 2012, the insurer holding Respondent's surety bond notified the  
20 Department that Respondent's bail agent bond was to be cancelled, effective 30 days from the  
21 date of the notice.

22 4. On August 17, 2012, the Department notified Respondent that the surety holding  
23 Respondent's bond was cancelling the bond effective September 6, 2012.



1 **NOTICE OF OPPORTUNITY FOR HEARING**

3 that Respondent may request a hearing pursuant to A.R.S. § 20-161 to contest the summary
