**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LICENSE  
AND NOTICE OF OPPORTUNITY  
FOR HEARING**

9 The Arizona Department of Insurance (the "Department") alleges that **Laura Ann**  
10 **Nickle** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the  
11 serious nature of these allegations, the Director of Insurance for the State of Arizona  
12 ("Director") finds that the public health, safety and welfare imperatively require emergency  
13 action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

- 15 1. Laura Ann Nickle ("Respondent") is licensed as a resident bail bond agent,  
 16 Arizona license number 976797, which expires on July 31, 2014.

  - 20 3. On August 6, 2012, the insurer holding Respondent's surety bond notified the  
 21 Department that Respondent's bail agent bond was to be cancelled, effective 30 days after  
 22 receipt of the notice.
