ORDER TO CEASE AND DESIST

The State of Arizona Department of Insurance ("Department") has received evidence that **Alex Salinas** unlawfully sold, solicited, or negotiated insurance contracts in the State of Arizona. Accordingly, the Director of Insurance of the State of Arizona (the "Director") makes the following Findings of Fact and Conclusions of Law and enters the following Order pursuant to A.R.S. § 20-292.

FINDINGS OF FACT

1. Alex Salinas ("Salinas" or "Respondent") was licensed to transact insurance in the State of Arizona as a Personal Lines (P&C) insurance producer, Arizona license number 941895 which expired on August 31, 2012.
2. Salinas' address of record is: 501 E. Ray Rd., #2, Chandler, Arizona 85225 (business, mailing and residence).
3. Salinas is not exempt from the licensing requirement.
4. Alexander Michael Salinas ("Alexander Salinas") is, and was at all times material, licensed to transact insurance in the State of Arizona as a property and casualty insurance producer, Arizona license number 915408 which expires on October 31, 2015.


1 **NOTICE OF OPPORTUNITY FOR HEARING**
