**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LICENSE AND  
NOTICE OF OPPORTUNITY FOR  
HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Colin Roy Moss** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

1. Colin Roy Moss ("Respondent") is licensed as a resident bail bond agent, Arizona license number 1028843, which expires on May 31, 2016.
2. Respondent's addresses of record are: c/o Regulator Bail Bonds, 23911 N. 25<sup>th</sup> Way, Phoenix, Arizona 85024 (business) and 2117 S. 48<sup>th</sup> St., Suite 106, Tempe, Arizona 85282 (mailing).
3. On August 8, 2013, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective September 17, 2013.
