**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LICENSE AND  
NOTICE OF OPPORTUNITY FOR  
HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Uriel Ibarra** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

1. Uriel Ibarra ("Respondent") is licensed as a resident bail bond agent, Arizona license number 1044176, which expires on December 31, 2016.
2. Respondent's addresses of record are: c/o Regulator Bail Bonds, 2125 S. 48<sup>th</sup> Street, #101, Tempe, Arizona 85283 (business and mailing).
3. On September 20, 2013, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective October 20, 2013.
4. On September 27, 2013, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective October 25, 2013.


9 Upon receipt of a timely written request for hearing, the Director will issue an order
