**ORDER SUMMARILY SUSPENDING  
BAIL BOND AGENT LINE OF  
AUTHORITY AND NOTICE OF  
OPPORTUNITY FOR HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Paul Hugh Sweeney** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

**FINDINGS OF FACT**

1. Paul Hugh Sweeney ("Respondent") is licensed as a resident accident/health, life, property and casualty insurance producer and bail bond agent, Arizona license number 869207, which expires on October 31, 2017.
2. Respondent's addresses of record are: 1413 N. 16<sup>th</sup> St., Phoenix, Arizona 85006 (business), and c/o WOW Insurance, LLC, 8912 E. Pinnacle Peak Rd., #227, Scottsdale, Arizona 85255 (mailing).
3. On November 26, 2014, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective December 26, 2014.
