**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE AND
NOTICE OF OPPORTUNITY FOR
HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Hernan Andres Vega** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Hernan Andres Vega ("Respondent") is licensed as a resident bail bond agent, Arizona license number 968826, which expires on June 30, 2018.
2. Respondent's addresses of record are: Downtown Bail Bonds, 1413 N. 16th St., Phoenix, Arizona 85006 (business and mailing).
3. On November 26, 2014, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective December 26, 2014.
4. On December 5, 2014, the Department notified Respondent that the surety holding Respondent's bond was cancelling the bond effective January 3, 2015.


9 Upon receipt of a timely written request for hearing, the Director will issue an order
