CONSENT ORDER

The State of Arizona Department of Insurance ("Department") has received evidence that **Katherine Kristine Bullerman** has violated provisions of Title 20, Arizona Revised Statutes ("A.R.S."). Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Katherine Kristine Bullerman ("Respondent") is, and was at all material times licensed as a resident personal lines (P&C) producer, Arizona license number 1098093, which expires March 31, 2018.
2. Respondent's addresses of record with the Department are: 12775 N. Running Coyote Drive, Tucson, AZ 85755 (mailing and business).
3. On or about December 3, 2014, the Department issued to Respondent an insurance license as a resident personal lines producer, Arizona license number 1098093.
4. On June 12, 2015, the Department notified Respondent by mail at her address of record that her fingerprint card had been processed and returned by the Arizona Department of Public Safety (DPS) as illegible. The Department requested a replacement set of fingerprints along with a completed "Illegible Fingerprint Replacement Form" on or before July 13, 2015. Respondent did not reply to the Department's request.

1 6. Respondent acknowledges that this Consent Order is an administrative action
2 that the Department will report to the National Association of Insurance Commissioners
3 (NAIC). Respondent further acknowledges that she must report this administrative action to
4 any and all states in which she holds an insurance license and must disclose this
5 administrative action on any license application.
