**ORDER SUMMARILY SUSPENDING
BAIL BOND AGENT LICENSE AND
NOTICE OF OPPORTUNITY FOR
HEARING**

The Arizona Department of Insurance (the "Department") alleges that **Ogden's Bail Bonds, LLC** has violated provisions of Arizona Revised Statutes ("A.R.S."), Title 20. In light of the serious nature of these allegations, the Director of Insurance for the State of Arizona ("Director") finds that the public health, safety and welfare imperatively require emergency action, within the meaning of A.R.S. §41-1092.11(B).

FINDINGS OF FACT

1. Ogden's Bail Bonds, LLC ("Respondent") is licensed as a resident bail bond agent, Arizona license number 954759, which expires on November 30, 2017.

2. Respondent's addresses of record are: 3610 E. Penny Lane, Cottonwood, Arizona 86326 (business); and PMB 497, 989 S. Main St., Cottonwood, Arizona 86326 (mailing).

3. On June 29, 2015, the insurer holding Respondent's surety bond notified the Department that Respondent's bail agent bond was to be cancelled, effective on July 26, 2015.


