**CONSENT ORDER**

**Respondent.**

The State of Arizona Department of Insurance ("Department") has received evidence that **Sarah Figueroa Fleming** ("**Respondent**" or "**Fleming**") violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

**FINDINGS OF FACT**

1. Fleming is, and was at all material times, licensed as an Arizona resident navigator, Arizona license number 1092259, which expires September 30, 2018. Fleming first became licensed with the Department on October 14, 2014.
2. Fleming's addresses of record are: 1402 S. 7<sup>th</sup> Ave., Phoenix, Arizona 85007 (business and mailing).
3. On or about October 14, 2014, Respondent submitted an Application for a Navigator License to the Department ("Application"). Section V of the Application asks: C. Has the applicant EVER been found guilty of, have you had a judgment made against you for, or have you admitted to any of the following: 1. A felony of any kind? Respondent answered "No" to Question C.1.





1           4.     Respondent states that no promise of any kind or nature whatsoever, except as  
2 expressly contained in this Consent Order, was made to her to induce her to enter into this  
3 Consent Order and that she has entered into this Consent Order voluntarily.

4           5.     Respondent acknowledges that the acceptance of this Consent Order by the  
5 Director is solely to settle this matter against her and does not preclude any other agency,  
6 including the Department, officer, or subdivision of this state or this agency from instituting civil  
7 or criminal proceedings as may be appropriate now or in the future.

8           6.     Respondent acknowledges that this Consent Order is an administrative action  
9 the Department will report to the National Association of Insurance Commissioners (NAIC).  
10 Respondent further acknowledges that she must report this administrative action to  
11 any and all states in which she holds an insurance license and must disclose this  
12 administrative action on any license application.


