CONSENT ORDER

Respondent.

The State of Arizona Department of Insurance ("Department") has received evidence that **Gary Lee Lane** violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Gary Lee Lane ("Lane" or "Respondent") is, and was at all material times, licensed as an Arizona non-resident accident/health, life, property and casualty insurance producer, Arizona license number 1083705, which expires January 31, 2018. Lane first became licensed with the Department on August 4, 2014.

2. Lane's address of record is: 2 Inglebrook, Irvine, California 92602 (business and mailing).

Revocation of Resident License

3. On or about July 21, 2014, the California Department of Insurance entered an Order of Summary Revocation In the Matter of the License and Licensing Rights of Gary Lee

1 Lane, File No. LBB 8863-A ("California DOI Order"). The California revoked Lane's resident
2 license, effective 30 days from the date of the order or on August 20, 2014.

3 4. Respondent failed to notify the Department of the California DOI Order within
4 thirty days.

5 **CONCLUSIONS OF LAW**

6 1. The Director has jurisdiction over this matter.

7 2. Respondent's conduct, as described above, constitutes failing to be currently
8 licensed as a resident and in good standing in the person's home state, within the meaning of
9 A.R.S. § 20-287(A)(1).

10 3. Respondent's conduct, as described above, constitutes violating any provision of
11 Title 20 or any rule, subpoena or order of the Director, within the meaning of A.R.S. § 20-
12 295(A)(2).

13 4. Grounds exist for the Director to deny, suspend for not more than twelve months,
14 revoke, or refuse to renew an insurance producer's license pursuant to A.R.S. § 20-295(A).

15 **ORDER**

16 IT IS HEREBY ORDERED THAT:

17 1. Respondent's license, Arizona number 1083705, is revoked, effective
18 immediately.




