CONSENT ORDER

Respondent.

The State of Arizona Department of Insurance ("Department") has received evidence that **Diana P Salomon ("Respondent" or "Salomon")** violated provisions of Title 20, Arizona Revised Statutes. Respondent wishes to resolve this matter without the commencement of formal proceedings, and admits the following Findings of Fact are true and consents to entry of the following Conclusions of Law and Order.

FINDINGS OF FACT

1. Salomon is, and was at all material times, licensed as an Arizona resident certified application counselor, Arizona license number 1091485, which expires December 31, 2017. Salomon first became licensed with the Department on October 9, 2014.

2. Salomon's addresses of record are: MHC Health Care 13395 N. Marana Main St., Marana, Arizona 85653 (business) and 3690 S. Park Ave., #105, Tucson, Arizona 85713 (mailing).

3. On or about October 9, 2014, Respondent submitted an Application for a Navigator License to the Department ("Application"). Section V of the Application asks: C. Has the applicant EVER been found guilty of, have you had a judgment made against you for,

1 or have you admitted to any of the following: 1. A felony of any kind? Respondent answered
2 "No" to Question C.1.

3 4. Subsection B of the Application states: You attest that you have read and
4 understand the foregoing. You certify, under penalty of denial, suspension or revocation of the
5 license and under any other penalties that may apply that the answers, statements and
6 information furnished in connection with this license application are true, correct and complete
7 to the best of your knowledge and belief. Respondent signed Subsection B of the Application.

8 **Felony Conviction**

9 5. On or about October 12, 1999, the United States District Court, District of
10 Arizona ("Court"), filed a Judgment in a Criminal Case in United States of America v. Diana
11 Patricia Salomon, No. CR 98-00454-002-TUC-JMR. The Court convicted Respondent of
12 Conspiracy to Possess with Intent to Distribute Marijuana, A Class C Felony.

13 **CONCLUSIONS OF LAW**

14 1. The Director has jurisdiction over this matter.

15 2. Before the Director approves an individual's certified application counselor
16 application, the Director shall find that the individual has not committed any act that is ground
17 for license denial, suspension or revocation as prescribed in A.R.S. § 20-295 and has not
18 been convicted of a misdemeanor involving fraud or dishonesty. A.R.S. § 20-336.04(B)(2).

19 3. Respondent's conduct, as described above, constitutes providing incorrect,
20 misleading, incomplete or materially untrue information in the license application, within the
21 meaning of A.R.S. § 20-295(A)(1).

22 4. Respondent's conduct, as described above, constitutes having been convicted of
23 a felony, within the meaning of A.R.S. § 20-295(A)(6).

1 4. Respondent states that no promise of any kind or nature whatsoever, except as
2 expressly contained in this Consent Order, was made to her to induce her to enter into this
3 Consent Order and that she has entered into this Consent Order voluntarily.

4 5. Respondent acknowledges that the acceptance of this Consent Order by the
5 Director is solely to settle this matter against her and does not preclude any other agency,
6 including the Department, officer, or subdivision of this state or this agency from instituting civil
7 or criminal proceedings as may be appropriate now or in the future.

8 6. Respondent acknowledges that this Consent Order is an administrative action
9 the Department will report to the National Association of Insurance Commissioners (NAIC).
10 Respondent further acknowledges that she must report this administrative action to
11 any and all states in which she holds an insurance license and must disclose this
12 administrative action on any license application.
